**A RESOLUTION ACCEPTING THE RESIGNATION

WHEREAS, Jonathan Schell has tendered his resignation as a Monticello City councilman.

WHEREAS, the acceptance of said resignation is in the best interest of Mr. Schell and the City of Monticello.

IT IS, THEREFORE, by the City Council of Monticello, Arkansas, resolved as follows:

1. That the resignation of Jonathan Schell is accepted, effective immediately.


2. A vacancy is declared to exist on the Monticello City Council for a representative of Ward 4.

3. Acting pursuant to Arkansas Code Annotated 14-43-411(a)(1) the Monticello City Council will, at it's next regular meeting, elect to the City Council a member that is a resident of Ward 4 to fulfil the remainder of the elected term of Jonathan Schell.

NOW, THEREFORE BE IT RESOLVED by the City Council of Monticello, Arkansas that the City of Monticello is authorized and directed to accept the resignation of Jonathan Schell as City councilman for the City of Monticello effective immediately and to elect a member that is a resident of Ward 4 to fulfil the remainder of the elected term of Jonathan Schell.


Please accept this letter as notice of resignation from my position as City Alderman, effective immediately.
