**RESOLUTION AUTHORIZING PURCHASE OF K-9 UNIT FOR MONTICELLO POLICE DEPARTMENT**

WHEREAS, the Monticello Police Department has requested authority to purchase K-9 Unit consisting of a properly trained dog and a 2010 Ford Expedition with K-9 equipment;

WHEREAS, the dog would be purchased from Von Klein Stein Kennel, Sherwood Arkansas, for a purchase of \$12,500.00;

WHEREAS, the Ford Expedition automobile would be purchased from West Carrol Parish Sheriff's Office for \$3,000.00;

WHEREAS, City Council accepts that the purchase of said K-9 Unit for Monticello Police Department in the best interest of the City of Monticello and authorizes said purchase;

WHEREAS, the purchase should be paid as follows:

Dog- General Fund Police Department Operating Budge Expense Line Item #5311 (Dog Pound)

Vehicle- General Fund Police Department Operating Budget Expense Line Item #5702 (Mach., Equip., Vehicle)

IT IS, THEREFORE, by the Monticello City Council resolved as follows:


1. That the purchase of a K-9 animal from Von Klein Stein Kennels, Sherwood, Arkansas for \$12,500.00 and a 2010 Ford Expedition automobile with all K-9 equipment from West Carrol Parish Sheriff's Office for \$3,000.00 is authorized.


2. That to the extent the purchase of the trained dog exceeds the City's bid limits (but not state limits) the purchase without the bid is authorized.

3. That the proceeds shall be paid from and charged to General Fund Police Department Operating Budget Expense Line Item #5311 (Dog Pound) and General Fund Police Department Operating Budget Expense Item #5702 (Mach., Equip., Vehicle)
