

ORDINANCE NO. 721

AN ORDINANCE FURTHER AMENDING SECTION 4 OF  
ORDINANCE NO. 445 OF THE CITY OF MONTICELLO RELATIVE  
TO FEES FOR PLUMBING INSPECTIONS; AND FOR OTHER PURPOSES

BE IT ORDAINED by the City Council of Monticello, Arkansas, as follows:

Section 1. That Section 4 (c) of Ordinance No. 445 of the City of Monticello adopted July 9, 1965, be and the same is hereby, amended to read as follows:

"Section 4. Applications; Permits; Fees.

"c. All applications for permits to do plumbing work shall be made on suitable forms provided by the City Plumbing Inspector. Each application shall be accompanied by payment of fees to the City of Monticello in accordance with the following schedule: \$30.00 for any number of plumbing fixtures not exceeding five, and \$1.00 for each plumbing fixture over five; and for natural gas inspections the fee shall be \$30.00 within the City of Monticello and \$35.00 outside the City. Permits must be obtained before any work commences. An additional fee of \$20.00 shall be charged for each additional inspection trip by the City Plumbing Inspector caused by the failure of the plumber to be ready for inspection or caused by the City Plumbing Inspector's having to return for inspection of a corrected installation."


Section 2. All ordinances or parts of ordinances conflicting with any of the provisions of this ordinance are hereby repealed to the extent of such conflict.
