

ORDINANCE NO. 725

AN ORDINANCE FURTHER AMENDING SECTION 2 OF  
ORDINANCE NO. 469 OF THE CITY OF MONTICELLO,  
ARKANSAS, PROVIDING FOR AN INCREASE IN THE  
FRANCHISE TAX PAID FOR THE PRIVILEGE OF ENGAGING  
IN THE BUSINESS OF PROVIDING TELEPHONE SERVICE  
IN THE CITY OF MONTICELLO, ARKANSAS

BE IT ORDAINED by the City Council of the City of Monticello,  
Arkansas, as follows:

( Section 1. Effective July 1, 2003, Section 2 of Ordinance No.  
469 of the City of Monticello, Arkansas, as previously amended, is  
hereby amended to read as follows:

"Section 2. The franchisee shall pay to the City,  
a franchise tax in the amount of 4.25% of the gross  
billing for all residential, commercial or industrial  
access lines in service within the corporate limits of  
City.

"For the year 2003, the franchisee shall compute the  
pro-rata portion of the tax due pursuant to Ordinance No.  
598 of the City of Monticello for the period between  
January 1, 2003 and June 30, 2003. Beginning July 1,  
2003 and ending December 31, 2003, the tax collected  
shall be computed pursuant to this ordinance. For year  
2004 and thereafter the tax shall be computed pursuant to  
this ordinance.


"The tax collected pursuant to this ordinance during year 2003 shall be paid to the City in four equal installments due February 1, 2004, May 1, 2004, August 1, 2004 and November 1, 2004. For year 2004 and subsequent years, quarterly payments shall be made on February 1, May 1, August 1 and November 1 of the year following the year in which the tax was collected."

Section 2. That all ordinances and agreements in conflict herewith are, to the extent of such conflict, repealed.


