

**AN ORDINANCE DESIGNATING ALL CITY OF MONTICELLO
PARK FACILITIES AS "TOBACCO FREE" AND THE
ENFORCEMENT THEREOF**

WHEREAS, the use of tobacco products on or in facilities of the City of Monticello Parks Commission (including, without limitation, Monticello Sports Complex, City Park, City Park swimming pool, Jordan Park and Jordan Park splash pad) is detrimental to the City of Monticello and the patrons of those facilities (including, without limitation, second hand smoke dangers, littering and cleanliness issues);

WHEREAS, it is therefore determined by the City Council of Monticello, Arkansas that it is appropriate to make all park facilities of the City of Monticello "tobacco free" and to provide for enforcement of that regulation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Monticello, Arkansas, as follows:

That all park facilities of the City of Monticello are to be "tobacco free" and the use of any tobacco product (including, without limitation, smoking tobacco, chewing tobacco and snuff) is prohibited.

The park facilities of the City of Monticello include but are not limited to, Monticello Sports Complex, City Park, City Park swimming pool, Jordan Park and Jordan Park splash pad.

Violation of this ordinance is punishable by a fine of \$25.00 in the Monticello District Court.

The use of tobacco products constitute a health risk and maintenance nuisance for the City of Monticello and the patrons of the city parks. Therefore, an emergency is declared to exist and this ordinance being necessary for the preservation of the public peace, health and safety of the citizens of Monticello shall be in full force and effect from and after it's passage.
