

RESOLUTION NO. RS-2016-10

A RESOLUTION CONFIRMING THE APPOINTMENTS OF CHRIS STUHLINGER, SAYEED MEHMOOD, LYNNE THOMPSON, HOPE BRAGG, LAURIE GHARIS, SUSAN SMITH, AND CLARE NORCIO TO THE MONTICELLO TREE BOARD.

WHEREAS, in November 2008 the Monticello Tree Board was created under authorization of Municipal Code §21-71 *et seq.* adopted under Ordinance 752; and

WHEREAS, in 2008 the Mayor appointed and the City Council confirmed the seven (7) initial members of the Tree Board for staggered one (1) and two (2) year terms, in compliance with Municipal Code; and

WHEREAS, since the initial appointments in 2008, no member has been reappointed or new members appointed to the Tree Board upon the expiration of the seven (7) initial terms; and

WHEREAS, seven (7) vacancies now exist as a members of the Monticello Tree Board; and

WHEREAS, the vacancies have occurred due to the expiration of said positions; and

WHEREAS, the Monticello Tree Board has recommended the appointment of the Chris Stuhlinger, Sayeed Mehmood, Lynne Thompson, Hope Bragg, Laurie Gharis, Susan Smith, and Clare Norcio to fill the respective vacancies; and

WHEREAS, in taking the recommendation of the Board, the Mayor has appointed the above to the Monticello Tree Board, in compliance with Municipal Code §21-71 *et seq.*

NOW THEREFORE, be it resolved by the City Council of the Monticello, Arkansas the following:

1. That the reappointment of Chris Stuhlinger is confirmed as a member of the Monticello Tree Board for a term ending at midnight, December 31, 2017.

2. That the appointment of Sayeed Mehmood is confirmed as a member of the Monticello Tree Board for a term ending at midnight, December 31, 2016.

3. That the reappointment of Lynne Thompson is confirmed as a member of the Monticello Tree Board for a term ending at midnight, December 31, 2017.

4. That the reappointment of Hope Bragg is confirmed as a member of the Monticello Tree Board for a term ending at midnight, December 31, 2016.


5. That the appointment of Laurie Gharis is confirmed as a member of the Monticello Tree Board for a term ending at midnight, December 31, 2017.
