A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE TWO (2) GRASSHOPPER ZERO TURN MOWERS THROUGH THE STATE OF ARKANSAS' COOPERATIVE PURCHASING CONTRACT PROGRAM.

WHEREAS, the City of Monticello has appropriated \$34,800.00 of funds in the 2016 Operating Budget, referenced in Resolution 2016-07, for the purchase of two (2) Grasshopper zero turn mowers in the Street and Parks Departments, respectively; and

WHEREAS, the mayor has recommended to the City Council the purchase of said items through the State of Arkansas' Cooperative Purchasing Contract Program, authorized by Municipal Code § 2-110, in the amount of \$31,239.25; and

NOW, THEREFORE BE IT RESOLVED by the City Council of Monticello, Arkansas that the City of Monticello is authorized and directed to purchase two (2) Grasshopper zero turn mowers through the State of Arkansas' Cooperative Purchasing Contract Program in the amount of \$31,239.25.
